

## TERMS AND CONDITIONS FOR THE PUBLICATION OF WORKS IN THE BOOK CHAPTERS OF THE 9th INTERNATIONAL/14th NATIONAL CONGRESS OF CLINICAL PSYCHOLOGY

---

Both **empirical and theoretical** works will be accepted. The presented works must contain the following headings: Title, Abstract, Keywords (both in Spanish and English), Introduction, Methods (Participants, Materials, Procedure and Design), Results, Discussion/Conclusion, Acknowledgements (if necessary), and References. Clinical cases must follow the structure suggested by Buéla-Casal and Sierra (2002), and Virués-Ortega and Moreno-Rodríguez (2008). **Deadline** for full text submission is **November, 30 (2016)**.

All the papers will be written according to the American Psychological Association (APA) formatting and style guide, published in the Publication Manual of the American Psychological Association (4<sup>th</sup> ed., 1994). **THOSE PAPERS THAT DO NOT FOLLOW THESE RULES WILL BE DISMISSED FROM THE REVIEW PROCESS.**

**IMPORTANT: WHEN PRESENTING A FULL TEXT WORK, THE AUTHORS ARE RESPONSIBLE FOR THE DOCUMENT'S ORIGINALITY, AND AGREE TO MAKE ANY CORRECTION AND RESPECT FORMAL ASPECTS (IF NEEDED).**

SUBMISSION RULES. **EXTENSION BETWEEN 2,500 and 3,000 words**

**The first page** must contain:

---

**Title** (Capital letter, Times New Roman, bold type, 12, centered, interlineal space: 1.5) in Spanish and English. If the work is written in English, the title should only appear in that language. You must have a descriptive nature of the work.

**Authors** (Times New Roman, bold type, 12, centered, interlineal space: 1.5).

- Author's name and surname of the authors must be indicated (if more than one surname is given, they must be separated by a hyphen), authors must be separated by a comma (,), the name of the last author must be preceded by "and".
- The corresponding author's contact information (email and address) must be indicated.
- Author's affiliation must be indicated in the following line\*  
\*Affiliation (Times New Roman, 12, italics, centered, interlineal space 1.5)  
\*Complete contact information, including address and e-mail.

**From the second page on**, the content must include:

---

- **Title** (again) (Capital letter, Times New Roman, bold type, 12, centered, interlineal space: 1.5).

## - **Text and epigraphs.**

The body of the text in each one of the sections must be written in Times New Roman, 12, normal, interlineal space 1.5).

Epigraphs (listed below) must be written in Times New Roman, 12, bold, left alignment, interlineal space 1.5., and should be the following:

- **Abstract:** 250-300 words. This section must appear in both English and Spanish. However, if the work is written in English, the abstract must be only in English.
- **Keywords:** 4-5 words. This section must appear in both English and Spanish. However, if the work is written in English, the abstract must be only in English.
- **Introduction:** The introduction must offer a brief overview of the present status of the field of interest, the work's relevance, and its objective. Relevant sources, scientific journals, and congress proceedings must be properly cited.
- **Method:** This section must contain the following parts: Participants, Materials/Instruments (including validity/reliability information), Procedure, and Design.
- **Results:** Note: If written in Spanish, decimals' digits must be separated by commas (,), instead of dots (.). For instance: 0,12. All the tables, figures, or graphics must be presented according to the APA style guides (4<sup>o</sup>. ed.). In English decimals should be written with dot (.) instead of comma (,) (see APA style guides).
- **Discussion/Conclusion:** Own results must be compared to those found in other studies. Strengths and weaknesses, along with possible limitations and future research must be discussed.

**References throughout the text must follow APA formatting and style guide** (4<sup>o</sup> ed.). Bibliographic citations must include the authors' last name and year of publication, both in brackets; when the name of the author is part of the text, only the year must be appear inside the brackets. If there are two or more references for the same statement, they must be ordered alphabetically. When the citation has more than two authors, but less than six, all the names must appear the first time they are cited, writing only the first name followed by "et al." in subsequent occasions. In case the citation has more than six authors, it must always be written specifying the first name followed by "et al.". If there are several papers written by the same author(s), all of them will be cited adding a, b, c, after the year of publication.

- **Acknowledgements** (if necessary) (Times New Roman, 12, normal, justified, interlineal space 1.5)

- **References:** They must strictly follow APA citation rules. Some examples are listed below:

**A. Books.** Must appear: Author's last name, coma, author's name's initial, period, year of publication in brackets (year), period, title of the book in italics, period, place of edition, colon, publishing house, and period. Example:

Campbell, D. & Stanley, J. (1978). *Diseños experimentales y cuasiexperimentales en la investigación social*. Buenos Aires: Amorrortu.

**B. Book chapters.** Must appear: Author's last name, coma, author's name's initial, period, year of publication in brackets (year), period, title of the book chapter, period. After that, it must be specified where to find the chapter, by writing: "In" followed by the author's name's initial and author's last name. Brackets will be used to write authors' affiliation, if they are directors (Dir. /Dirs.), editors (Ed. /Eds.), and right after their names. Following that, the name of the book must be written in italics, and in brackets the pages where the chapter appears, separating the first and last pages by a hyphen, and preceded by pp. . Then: place of edition, colon, publishing house, period. Example:

Gual, A. (2006). Alcoholismo. In J. Vallejo (Ed.), *Introducción a la psicopatología y la psiquiatría* (pp. 599-613). Barcelona: Elsevier-Masson.

**C. Published papers.** Must appear: Author's last name, coma, author's name's initial, period, year of publication in brackets (year), period, title of the paper, period, name of the magazine in italics, volume and number in italics, and the pages where you can find it separated by a hyphen. Example:

Bermúdez, M.P., Castro, A., Madrid, J., & Buela-Casal, G. (2010). Análisis de la conducta sexual de adolescentes autóctonos e inmigrantes latinoamericanos en España. *International Journal of Clinical and Health Psychology*, 10, 89-103.

**D. Other documents: Web pages.** Name of the author or institution that has written the document, period, year when the document was written in brackets, period, name of the document in italics, and period. After that, it must be specified when and from where the document was taken. Example:

Bravo, R., Echeburúa, E., & Aizpiri, J. (2008). *Diferencias de sexo en la dependencia del alcohol: dimensiones de personalidad, características psicopatológicas y trastornos de personalidad*. Retrieved from <http://www.infocop.es> the 15th of October, 2010.

#### **E. Alphabetical Order.**

1. Bibliographic references must be written in alphabetical order, according to the author's (or first author's in case there are more than one) name and last name.
2. If one same author has several papers, they will be ordered according to the year of publication. Example:

Moral, M.V. & Ovejero, A. (2006). Ocio dionisíaco y experimentación con sustancias psicoactivas: aproximación crítica desde la Psicología Social. *Revista de Psicología General y Aplicada*, 59, 241-255.

Moral, M.V. & Ovejero, A. (2009). Experimentación con sustancias psicoactivas en adolescentes españoles: perfil de consumo en función de los niveles de edad. *Revista Latinoamericana de Psicología*, 41, 533-554.

3. If they match both the author / s, and the date, should be sorted by the first word of the title of the work.
